Teacher Training

1. Provide a description of the activities that prepare general education teachers to:

a. Teach students with disabilities effectively

Our general education teacher candidates collaborate with special education teachers and are required to complete an Introduction to Exceptional Learners course across programs. This course gives an overview of exceptionality as it pertains to children and adults. Each area of exceptionality is reviewed in terms of etiology, diagnosis, prevalence, remediation, and educational strategies. Other activities include students participating in case studies that teach them the components of an IEP as well as working as a team member to develop and IEPs. General education students participate as a member of a mock IEP meeting. They are required to develop lesson plans, and complete face-to-face observations with individuals with disabilities. Behavior plans, medical records and various services recommended for individuals with disabilities are taught in the courses. Faculty distribute many resource guides electronically to all students. Candidates learn about methods to support all learners as they engage in methods, assessment, classroom management, and field coursework. Differentiating instruction is a particular focus. Instructors discuss and share strategies with students to promote better understanding of the roles and responsibilities of teachers, service providers, and parents of children with disabilities.

b. Participate as a member of individualized education program teams, as defined in section 614(d)(1)(B) of the *Individuals with Disabilities Education Act*.

Students are required to participate in case studies that teach them the components of an IEP as well as working as a team member to develop IEPs. General education students participate as a member of a mock IEP meeting. Each student must complete an IEP based on case studies discussed in class.

c. Effectively teach students who are limited English proficient.

Program goals being proposed in our education programs to effectively teach students who are limited English proficient are as follows: Goal 1. As teacher educators, MA/ESL faculty will model the vibrant, dynamic relationships with candidates needed to build teacher-student trust that encourage students to take academic/language risks in the classroom. Goal 2. MA/ESL faculty will model effective online teaching practices in teacher education online courses. Goal 3. MA/ESL faculty will seek opportunities for candidates to gain experience implementing effective teaching practices with diverse English learners.

Our Special Education Program features interdisciplinary, graduate-level courses that are both rigorous and innovative. We offer specialties such as the Collaborative Teacher (CT) K-6 and 6-12 and Early Childhood Special Education (ECSE). We also have a Collaborative Special Education Degree with a concentration in reading. Students learn early intervention and preschool curriculum and methods, collaborative processes, technology

applications, physical and healthcare support in early childhood education, lesson planning, and positive behavioral supports. Classes are offered online and in blended formats that combine both online and on-campus sessions.

b. Participate as a member of individualized education program teams, as defined in section 614(d)(1)(B) of the *Individuals with Disabilities Education Act*.

Students are required to participate in case studies that teach them the components of an IEP as well as working as a team member to develop IEPs. General education students participate as a member of a mock IEP meeting. Each student must complete an IEP based on case studies discussed in class. Special Education students' classes involve components of preparing and implementing IEPs. Issues in Special Education and the laws that protect individuals with special needs

c. Effectively teach students who are limited English proficient.

To address diverse learning preferences and shifting trends in information delivery, in our education programs we are proposing that MA/ESL faculty include podcasts, videos, and a variety of digital tools for sharing content from multiple perspectives. To encourage active participation, videos are embedded with questions for candidates to respond to immediately. Most importantly, MA/ESL faculty are creating opportunities for candidates to practice teaching English learners in online contexts. The Community English Program provides an online academic writing course for adult English learners within the UAB professional community and for the greater Birmingham area. MA/ESL faculty are preparing for UAB masters' students who participate in local ESL summer camps to lead online learning experiences for English Learners in elementary and middle school.
