

# **Policy for the Recent Professional Experiences Requirement**

Effective Fall Semester, 2018

### Article I: Alabama State Department of Education (ALSDE) Code Requirements, 2015

#### **Recent Experience**

SUPP.NO.15-3 290-3-3-.01(43) Recent P-12 Experiences Requirement. A written policy enforced by an EPP to ensure that faculty who teach professional education courses or supervise interns and who have not been employed in a P-12 setting within the most recent five-year period spend sufficient time in P-12 schools to maintain current knowledge of what is experienced by currently employed P-12 educators.

#### **Professional Education Courses**

(39) Professional Studies. A coordinated and integrated program of courses and experiences that includes foundations, methodology, curriculum, evaluation, reading, technology, direct observation and participation in a variety of school settings, and internship. Professional studies courses are typically common to multiple disciplines or areas.

#### Section 1.01 Preparing for Recent P-12 Experiences

- (a) This policy applies to all faculty and adjunct instructors teaching professional education courses, including methods courses, or supervising interns who have not been employed in a P-12 setting within the most recent five-year period. Department Chairs shall communicate this policy to program faculty, adjuncts, and supervisors at the beginning of each academic year.
- (b) Effective immediately, UAB faculty and adjunct instructors who are required to complete the Recent Experience policy must clear a criminal background check through UAB no later than December 31, 2018. Faculty members who have previously cleared a criminal background check through the Alabama State Department of Education, however, will not have to complete UAB's criminal background check provided that a cleared background check is downloaded from the Alabama State Department of Education Teacher Certification Portal. There is no cost to faculty for completion of the UAB criminal background check. Background checks should be housed within the hiring department.
- (c) If faculty or adjunct instructors propose to conduct their recent professional experiences in a private school, this school must be accredited by SACS or approved in advance. A list of accredited schools is provided at: <u>http://www.sacscasi.org/</u>. For program areas that include faculty or adjunct instructors who typically would not teach in SACS-accredited sites (e.g., Early Childhood Education),

completion of these experiences may be completed at a quality site, relevant to their field as negotiated with the Department Chair.

## Section 2.01 Conducting Recent P-12 Experiences

- (a) Recent P-12 teaching experiences may be conducted throughout the year (May 15-May 14) in SACS-accredited schools, other approved sites, or during the summer in public schools. Experiences must be documented during the 12-month period from May 15 to May 14. Experiences should reflect the quality of faculty professional fields. If the experience is conducted in a private school, it must be SACS-accredited, and the faculty members are responsible for making sure that the school is on the accredited list. In unique program areas (e.g., Early Childhood Education, Educational Foundations, Educational Psychology and Research, Counselor Education, Kinesiology, and School Psychometry) where school sites may not be SACS-accredited, faculty should verify the eligibility of experiences with their Department Chair.
  - i. <u>Methods Faculty</u> must maintain connections to P-12 schools for a total of no less than twenty hours per academic year (May 15 to May 14). At least one of those experiences must include teaching, co-teaching, guest-teaching, or conducting demonstrations in P-12 settings. All individuals designated as methods faculty are encouraged to conduct their recent teaching experiences in high-need and diverse areas, especially those that are identified as SOE partners. Faculty are encouraged to invest their time across different locations as appropriate to their major field of study and research.
  - ii. <u>Non-Methods Educator Preparation Faculty</u> teaching a professional education course (See Appendix A and B) must complete at least one independent experience per academic year (May 15 to May 14) that reflect experiences in P-12 schools. Qualifying P-12 school experiences include, but are not limited to, (1) classroom observation; (2) classroom support; (3) co-teaching; (4) guest teaching; (5) conducting demonstration lessons; and (6) educational research and/or program evaluation. All individuals designated as non-methods educator preparation faculty are encouraged to conduct their recent P-12 experiences in high-need and diverse schools, especially those which are identified as SOE partner schools. Faculty are encouraged to invest their time across different locations and/or settings as appropriate to their major field of study and research.

Note: If a faculty member teaches both methods courses and professional education courses, the methods faculty documentation takes precedence.

 iii. <u>Instructional Support Faculty and Supervisors</u>: At the end of every academic term, instructional support faculty and supervisors will need to document qualifying experiences that ensure they are thoroughly familiar with the current professional responsibilities of P-12 practitioners in the field(s) in which they supervise interns and/or teach. The Director of Clinical Experiences must approve all experiences for clinical supervisors of student teaching. Department Chairs must approve experiences for all additional instructional support faculty and supervisors.

# Section 3.01 Documenting Recent P-12 Experiences

(a) All Methods Faculty, Educator Preparation Faculty, and Instructional Support Faculty and Supervisors will report recent experience through the following link: <u>https://uab.co1.qualtrics.com/jfe/form/SV\_eF2QXtAyguXo4e1</u>

Reported information will be used for the following purposes: CAEP accreditation, ALSDE reports, annual evaluations, individual faculty reports of teaching and service, eligibility for rehire, and reports for other entities.

## Annual and Term Reporting deadlines are as follows:

Methods Faculty: Each year on or before May 14

Educator Preparation Faculty: Each year on or before May 14

Instructional Support Faculty and Supervisors: On or before the last day of the contracted academic term for either (1) adjunct teaching of a professional education course; or (2) supervision of an internship or practicum. Instructional support faculty need to complete only one qualifying experience over the course of the annual reporting cycle (May 15-May 14). Failure to report recent experience will result in the withholding of your final employment compensation payment.

# Section 4.01 Definitions

**Methods Faculty** members are those who teach School of Education courses pertaining to pedagogy (e.g., the word methods would probably be in the course title). This methods faculty designation also includes adjunct faculty, faculty in the Arts and Sciences who teach methods courses, and field supervisors of interns in a teaching field.

**Non-Methods Educator Preparation Faculty** are full-time faculty or instructors who teach a School of Education professional education course.

**Instructional Support Faculty and Supervisors** include adjuncts, clinical supervisors and internship supervisors of educator preparation programs. Instructional support faculty and supervisors are encouraged to conduct their recent shadowing experiences in high-need and diverse areas, especially those which are identified as SOE partner schools.

Appendix A

## Methodology for Professional Education Course Selection

Professional Education Courses are defined in the following section of the Alabama State Department of Education CODE:

SUPP.NO.15-3 290-3-3-.01(39) Professional Studies. A coordinated and integrated program of courses and experiences that includes foundations, methodology, curriculum, evaluation, reading, technology, direct observation and participation in a variety of school settings, and internship. Professional studies courses are typically common to multiple disciplines or areas.

Affected courses are identified annually according to the following **approved checklist** criteria:

- Class B Early Childhood, Elementary, Music Education, Physical Education, and Secondary: All courses listed under "Professional Studies" AND "Methods\*" found under "Teaching Field."
- Class Alt A Art Education, Early Childhood Special Education, Elementary Education, English as a Second Language, Music Education, Secondary Education, Special Education, and World Languages: At least ONE course found under (1) Curriculum; (2) Methods of Teaching\*; (3) Diverse Populations; (4) Literacy; (5) Professionalism; (6) Using Assessment Data to Improve Student Learning; (7) Survey of Special Education Coursework; and (8) Internship.
- Class Alt A Physical Education: Courses listed under "Teaching Field" with direct P-12 content alignments.
- Class A Early Childhood and Elementary Education: Courses found on p. 1 under "Teaching Field" AND "Additional Courses."
- Class A Art Education, Music Education, Reading, and Physical Education: All courses listed under "Teaching Field" AND at least ONE courses listed under "Additional Requirements."
- Class A Secondary Education: All courses listed under "Curriculum and Instruction" AND "Survey of Special Education Coursework."
- Class A School Counseling and School Psychometry: All courses listed under "Instructional Support Area."
- Class A Early Childhood Special Education and Special Education: All courses listed under "Teaching Field."
- Class A Instructional Leadership: All courses listed under "Instructional Leadership Courses" AND "Practicum."
- Class AA Early Childhood and Elementary Education: All courses listed under (1) Teaching Field; (2) Diversity; (4) Research; (5) Survey of Special Education Coursework; and (6) Other Required Courses.

- Class AA Special Education: All courses listed under "Teaching Field" AND at least ONE course listed under "Additional Courses."
- Class AA Secondary Education: At least ONE course found under: (1) Curriculum and Instruction; (2) Diversity; (3) Research Sequence; and (4) Survey of Special Education Coursework.
- Class AA Physical Education: At least ONE course found under each the following checklist headings: (1) Teaching Field; (2) Diversity; (3) Research Sequence; and (4) Survey of Special Education Coursework.
- Class AA Instructional Leadership: All courses listed under "Instructional Support Area" AND "Practicum."

\*Methods courses are a sub-set of professional education courses. Methods Faculty are those who teach identified methods courses found in Appendix B.
