# **Plenary Session Speakers**



**Richard M. Allman, MD,** Parrish Endowed Professor of Medicine and Director of the UAB Division of Gerontology, Geriatrics, and Palliative Care, has expanded the research, education, and service programs in aging through his leadership of the UAB Center for Aging, the Southeast Center of Excellence in Geriatric Medicine (SCEGM), the Birmingham/Atlanta VA Geriatric Research, Education, and Clinical Center (GRECC), and the Deep South Resource Center for Minority Aging Research (RCMAR). He has served as the principal investigator for the NIA-funded UAB Study of Aging since 1998.

Dr. Allman has been listed in *Best Doctors in America* since 1991 and has played important leadership roles in the American Geriatrics Society, the Association of Directors of Geriatric Academic Programs, and the National VA GRECC Directors' Association. He was inducted as a permanent member of the Alabama Senior Citizens' Hall of Fame and received the Robert G. Sherrill Quality Champion Award from AQAF in 2009 in recognition of his efforts to improve the health and well-being of older adults in the state.



Wendy Demark-Wahnefried, PhD, RD, Professor and Webb Endowed Chair of UAB Nutrition Sciences and Associate Director for Cancer Prevention and Control, is a nutrition scientist with training in biochemistry, genetics, and behavioral science. Her research career has spanned basic science studies focused on determining mechanisms of action of food-related components on neoplastic progression, to clinical research that involves nutrition-related concerns of cancer patients, as well as determining effective lifestyle interventions that improve the overall health of cancer survivors and populations at

high risk for cancer. Her laboratory has conducted some of the largest studies exploring metabolic and body composition changes in response to cancer treatment. Dr. Demark-Wahnefried has experienced particular success in the delivery of home-based lifestyle interventions among cancer survivors and has led a number of NIH-funded trials aimed at improving the diet and exercise behavior of cancer survivors. She was a named a Komen Professor of Survivorship for this work.



**Linda D. Moneyham, DNS, RN, FAAN,** Professor and Rachel Z. Booth Endowed Chair, UAB School of Nursing, Department of Community Health, Outcomes and Systems, has an established program of funded research focused on developing and testing of interventions supportive of rural women with HIV disease. Since 1999, Dr. Moneyham has been testing a peer-based social support intervention aimed at decreasing depressive symptoms and increasing disease management and quality of life. Her research has been funded by a number of grants from the Centers for Disease Control and Prevention (CDC) and

the National Institutes of Health. She is experienced in instrument development and both qualitative and quantitative research methods. Dr. Moneyham is an expert in the use of focus group methods in formative research supportive of the development of culturally sensitive interventions and field research methods.



**Kenneth G. Saag, MD, MSc,** Jane Knight Lowe Professor of Medicine, Division of Clinical Immunology Rheumatology, and Professor of Epidemiology, UAB School of Public Health, is the founding Director of the Center for Education and Research on Therapeutics (CERTs) of Musculoskeletal Disorders, Associate Director of the Multidisciplinary Clinical Research Center (NIAMS P60), and Director of the UAB Center for Outcomes and Effectiveness Research and Education (COERE). He is a practicing rheumatologist and outcomes researcher with expertise in musculoskeletal disorders (MSD) and

pharmacoepidemiology and has a clinical focus in bone health. Dr. Saag is experienced in designing and conducting clinical trials in the therapeutics of MSD and in population-based investigations. He is has served on the FDA Arthritis Advisory Committee and co-chaired the American Medical Association (AMA) Physician Consortium for Performance Improvement on Osteoporosis. He is on the editorial board of *Annals of Internal Medicine, Arthritis Research and Therapy*, and *Arthritis Care and Research*.



**Selwyn M. Vickers, MD, FACS,** Jay Phillips Professor and Chairman, Department of Surgery at the University of Minnesota, and Associate Director of the Masonic Cancer Center, is a former Chair of UAB General Surgery and Co-Director of the UAB Minority Health and Health Disparities Research Center (MHRC). Dr. Vickers specializes in pancreatic, bile duct, and gastrointestinal cancer. His research interests include gene therapy as an application in the treatment of pancreatobiliary tumors and the role of growth factors and receptors in the oncogenesis of pancreatic, hepatobiliary, and

gastrointestinal surgery. He currently serves on the editorial boards of *Archives of Surgery, Journal of Surgical Research, Yearbook of Surgery, The American Journal of Surgery,* and *Journal of Gastrointestinal Surgery.* He is an adhoc reviewer for *Surgery, Mosby Yearbook of Surgery, Gastroenterology, Clinical Center Research,* and *Cancer Research.* He recently was appointed as a Director for the American Board of Surgery and was elected to the Institute of Medicine. Dr. Vickers is listed in *Best Doctors in America.*
